## **GO FOR THE GOLD!**

1/3 GOLD and 2/3 RED MPs will be awarded for players finishing in the overalls of Gold Rush Pair events *and* Gold Rush Bracketed Swiss events.

Players who place first in either direction of a two-session Pairs event also receive 1/3 GOLD. If a player is first in either direction of a side game, AND they play at least two games in the same series, 33% of the points will be GOLD.

Additional GOLD may be earned by players in the side series overalls.

# All players participating in NLM Regional events <u>MUST</u> be Non-Life Masters with fewer than 750 master points. All sessions are averaged.

All tournament players must have an ACBL member number to participate (even if membership has expired). Lapsed members do not have to rejoin but will pay a \$4 surcharge per session (in addition to session entry fees).
