BOARD OF DIRECTORS MEETING September 22, 2018

Old Business:

1. Debbie Monroe opened the meeting and discussed her goals for the meeting.

- 2. Minutes of the July 28, 2018 board meeting were approved with the following amendment: #4 Old Business to clarify what the "primary reasons" referenced. Having a free game hardly explains why there were 17% fewer tables. The second sentence should be changed to "the primary reasons for revenue loss..."
- 3. Dixie Culver had previously e-mailed the Treasurer's Report as of August 31, 2018, as well as July 2018 and August, 2018 activity. As of August 31, 2018, CCBA had \$27,535 in the checking account and two CD's. This was \$3,621 more than a year ago. The reason is due to a profit of almost \$3K at the WS Sectional.
- 4. The Unit Game final is 17% below prior year tables. The primary reasons for the loss in the last 12 months were (1)the Christmas party, (2) the free Alzheimer's game, (3) the free Mentoring game and (4) lower average attendance at the unit games. These variances were partially offset by charging \$8/game and by charging \$5.00/person for the Holiday party. As discussed by Bob at the last meeting, attendance seems to be stabilizing. We should look at ways to keep from losing any more money on the unit games.
- 5. We have new debit/credit cards that replaced the existing Discover credit cards. The new debit/credit cards are with Capital Bank (was recently acquired by First Tennessee) where the bank accounts and CD's are currently. Bob Hale has canceled the Discover credit cards. The bank did not accept our application for regular credit cards.
- 6. Kent Leggette along with Jeannie Leggett presented the unit game calendar for 2019. There is an additional game in GSO in December pending availability of Lewis Rec Center. An additional week of unit championship games at the clubs may be possible. Kent also, announced the dates for the unit 169 Sectional in 2019, as well as, preliminary dates for 2020. Having another NLM Regional is undetermined at this time.

New Business:

- 1. Debbie Monroe proposed the "Willie" Unit 169 Player of the Year award. This would recognize the player earning the most master points at unit games and sectionals during a calendar year. Tim Stecker offered to maintain the data. The award will commence in 2019. There was concern about the name, board agreed to naming award Unit 169 Player of the Year, with understanding that name may be changed at a later date.
- 2. Debbie informed all in attendance that the next board meeting will be Saturday, November 17, 2018 in Winston Salem at 10:45 am. She then adjourned the meeting at about 12:00.
